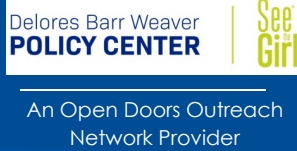


THE OPEN DOORS OUTREACH NETWORK

NORTHEAST FLORIDA REGION JUST THE FACTS



OVERVIEW

In Florida's Northeast Region, the Open Doors Outreach Network is an innovative program of Voices for Florida in partnership with Delores Barr Weaver Policy Center. It is a 24/7 network of care for victims and survivors of commercial sexual exploitation and trafficking ages 10-24.

PURPOSE

Florida ranks third in the nation for reports of human trafficking. Despite Florida's passage of the Safe Harbor Act in 2012, gaps in services for victims remained. To close these gaps, enhance coordination and improve care, Voices for Florida, in partnership with Children's Home Society, began piloting the Open Doors Outreach Network in Northeast Florida in July 2017.

24/7/365 MODEL OF CARE

Utilizing promising best practices and advances gleaned from translational research, trauma-competent services are provided 24/7/365 by Outreach Teams consisting of one or more: Survivor-Mentor, Regional Advocate and Clinician. Together, the team builds trusting relationships with victims, develops and provides treatment plans, makes connections with community services and creates public awareness and partnerships.

KEY PRINCIPLES OF THE MODEL INCLUDE:

VICTIM-CENTERED Preventing re-traumatization by ensuring victims have self-determination and gain access to services in accordance to their needs and wishes – rather than being forced.

SURVIVOR-LED Survivor-Mentors, who have experienced trauma themselves, are able to further elevate the voice of those being served.

COORDINATED NETWORK Services are standardized among all 32 counties being served. Services follow the survivor if they move throughout the network regions, creating seamless transition of care plans.

CROSS-SECTOR COLLABORATION Services provided are often based on partnerships with other agencies and sectors, including DCF, DJJ, DOH, law enforcement, etc. This approach allows Outreach Teams to work collaboratively to identify gaps and leverage existing resources to best meet clients' needs.
